You're familiar with IRA, 401(k) or 403(b) retirement plans. Path2College is similar, but it's used to save for higher education. Path2College is a state-sponsored, tax-advantaged 529 college savings plan that's helping families and individuals plan for the cost of higher education. With a minimum contribution of \$15 per pay period (\$25 if using another contribution method), low fees, and a tax deduction for Georgia residents, Path2College makes saving affordable. Because you may contribute directly from your payroll with direct deposit, it's simple, too.

Parents, grandparents, or anyone can save for a child's future education or even their own ongoing training. Funds can be used to pay for expenses such as tuition, room & board, books and computers at universities, colleges, trade schools, professional schools and graduate programs. Make the most of your savings by contributing to your account regularly. **You can contribute by payroll direct deposit for as low as \$15 per pay period.**

Any earnings have the opportunity to grow tax-deferred and withdrawn state and federal tax-free when used for qualified education expenses. **Georgia residents who contribute to a Path2College account may be eligible for a state tax deduction.** (Limitations apply*.)
